A Regular Meeting of the Mayor and Council of the Borough of Hasbrouck Heights was held on Tuesday, October 28, 2008 at 8:04 p.m. at Borough Hall, 320 Boulevard, Hasbrouck Heights, New Jersey.

Borough Clerk Rose Marie Sees stated that the meeting complied with the Sunshine Law, adequate notice of this meeting having been made to all members of the Council by personal service on January 2, 2008 and transmitted to The Observer, The Record and The Herald News on January 2, 2008.

On a motion by Councilman DiPisa, seconded by Councilman DiNanno, and unanimously carried, the foregoing Resolution was adopted.

REPORTS:

POLICE: Under Police, Mayor/Commissioner Heck first thanked everyone for getting the Oldfield Avenue project moving, with the work being paid for by the property owner and the sidewalk and guide rail on Washington Place to be completed in the next week. She reported on the Police Department News, noting that two new patrol vehicles were placed into service to replace the old Traffic Dept. SUV and a patrol car. The semi-annual firearms qualifications was conducted at the pistol range. Chief Colaneri, Captain Cronin and Patrolman Donohue received training in the new reverse 9-1-1 notification. A DWI checkpoint was held on October 18, 2008, resulting in four arrests, two for CD and six revoked and nine impounds. Chief Colaneri asked for various youth events to be held on Mischief Night and that parents keep their children home that night. Curfew will be strictly enforced. Ron Ingui of RC Landscaping was thanked for planting new mums at the Police Memorial. Mayor Heck thanked the DPW for planting mums around the Circle. Summons for the month of September included 347 Parking violations versus 475 in August 2007, with year to date totals for 2008 - 3,613 and in 2007 - 3,751. Moving violations were 221 versus 179 in 2007, with a year to date of 1,639 in 2008 and 1,725 in 2007. Total Violations were 568 in September 2008 and 654 in September 2007, with a year to date of 5,252 in 2008 and 5,476 in 2007. Under the General Complaints report, she noted there were 84 ambulance requests, 3 Teterboro ambulance requests, 11 ambulance w/paramedics, 3 animal bite, 24 animal complaints, 28 assisting other agencies, 1 attempted suicide, 1 auto theft, 11 ordinance violations, 27 commercial burglar alarm complaints, 22 residential burglar alarm complaints, 2 burglary-residential, 1 carbon monoxide alarm, 45 cell phone 9-1-1 calls, 1 child custody dispute, 8 criminal mischief business, 12 customer disputes, 14 disabled vehicles, 2 disorderly conduct, 2 disorderly conduct fight, 18 domestic violence calls, 10

domestic violence orders, 6 DUI, 1 erratic driver, 3 family dispute, 12 Fire, 28 fire alarms, 2 fraud bad checks, 3 gas leaks, 45 general complaints, 2 general disputes, 3 harassments, 2 identity theft, 1 juvenile runaway, 4 juvenile delinquency, 6 juvenile incidents, 11 lock out of motor vehicle, 2 lock out residence, 4 lost articles, 1 missing person, 7 neighbor disputes, 18 noise complaints, 1 possession opium/cocaine, 4 property damage, 2 recovered motor vehicle, 6 sewer backup, 25 suspicious incidents, 27 suspicious persons, 18 suspicious vehicles, 12 Teterboro 9-1-1 calls, 5 theft, 3 theft from auto, 2 theft of bikes, 17 traffic accidents county roads, 9 borough traffic accidents, 12 traffic accidents-private, 34 traffic accidents state roads, 102 traffic enforcement, 49 traffic related services, for a total of 1,066 complaints.

FINANCE , HEALTH & PUBLIC FACILITIES: Under Finance, Councilman DiPisa read the following Finance Report: the current fund cash balance as of September 30, 2008 was \$1,518,849.13; on August 31, 2008 was \$4,015,349.25, which represents a decrease of \$2,496,500.12. The entire balance was invested and is earning 2.29%. Cash receipts for September totaled \$793,061.86 of which \$219,377.21 was for current taxes, \$3,799.11 was for prepaid taxes, \$405,116.40 was State Aid, and \$164,769.14 was miscellaneous revenues. Cash disbursements for September totaled \$3,289,561.98 of which \$1,697,323.83 was local school taxes, \$592,160.26 was salaries, \$487,789.38 was Debt Service and \$512,288.517 was for other expenses. He continued that on Oct. 21, Mayor Heck and members of the Finance Committee, including Councilman DiPisa, Councilwoman Buckman and CFO/Admin. Michael Kronyak held an open forum to discuss local taxes and the municipal budget process with approximately 35 residents in attendance. Under Health, he reported on October 18, a Health Fair Expo was held with number of vendors increasing and the turnout good. He thanked Lori French, Pam Link and the members of the Board of Health. He continued that Flu shots for residents over 65 years of age will be held on November 7. Under Public Facilities, he reported the heating system was turned on and inspected in Borough Hall, the heater at the Franklin Avenue Pump Station was serviced and the double doors in Borough Hall received maintenance. The Masonic Education Center entry way was painted by the DPW. Events held in Borough Hall included 13 in the Community Room, 7 in the Caucus Room, 8 in the Senior Center (not including Senior activities), 4 in the Council Chambers and 1 in the Recreation Center. As Recycling Liaison, he reported under the Hasbrouck Heights Recycling Programs, giveaways were provided to the Environmental Commission who handed out biodegradable leaf bags, cloth grocery shopping bags, coloring books and crayons, rulers and pencils and recycling logo stickers at Town Day.

SOCIAL SERVICES: Under Social Services, Councilwoman Saccomano reported the following Food Drives were held and many items delivered for the Food Pantry this past month. Lincoln School PTA/Dina Pomerico, Cub Scout Pack 17/Ken Hesse, Corpus Christi Brown Bag Sunday, St. John's Episcopal Church and the United Methodist Church. Generous monetary donations and/or gift cards were received from the Crop

Walk, Town Day, Bertha Spada and Madelyn Sandner. This is in addition to the many bags of groceries received, some generous givers bringing bags of items in weekly – Kathy and Veronica Van Jura, Kay Hoffman, McCarthy Family, Pat Thomasey, Josephine, Melissa Nazzaro, Laura Baker, Bernice Baker, Gloria Cotter, Arlene Carreau, Ginny Santoro, Mr. Kinzley, Mr. Marcus, Lynn Taylor, Carla Caulkin, Mrs. Bright, Kristen and Ryan. She reminded residents that turkeys will be accepted for the holidays.

PARKS: Under Parks, Commissioner DiNanno reported the DPW had cleaned up Woodland Park in preparation for Town Day which was held October 4. A tree that had split in half during a storm, was removed from the area that hung over the organization tables and fallen limbs were removed throughout the park. Mums were planted around the Circle by the DPW and Girl Scout Troop 606 provided and planted mums around the Message Board outside Borough Hall. A special thanks was extended to Mrs. Presti and the girl scouts on a job well done.

TRANSPORTATION: Under Transportation, Commissioner Altobelli reminded the public that Teterboro Airport improved the ability to report noise complaints, jet fumes and window rattling, etc. by calling 201-288-8828 or online by www.teb.com. A response should be received within a day or so. Reports to the Airport were important to monitor feedback.

LAND USE & RECREATION: Under Land Use, Commissioner Buckman reported under property maintenance, there were 14 complaints made with ten resolved and four still pending, nine verbal warnings, five written violation warnings, two verbal warnings for placing garbage on the curb too early, two summonses issued, two summonses heard in Municipal Court, two warning letters mailed, one verbal stop work order for not having a permit, and two verbal stop work orders for working past the allotted time on Saturday, Under Recreation, she reported that Town Day was held on October 4, with “Double Tap” performing and the Fire Department demonstrating life saving scenarios. Over 35 town organizations participated. Halloween in the Park was held October 16, and all involved were thanked, Al DeAngelo, Tony Bonillo, John Baratta, Eileen Kiick, Ed Gumbrecht, Pat Link, Lori French, Pat Campen, Chris Zamski and Fun Time Entertainment, Ray Vorisek of Heights Flower Shoppe and student volunteers, Peter Bothe of the B.C. Parks Department for the hayride, the Hasbrouck Heights Police, Fire and DPW departments. The Commissioner personally thanked Rob Brady for organizing these events. Registrations were still being accepted for Youth Basketball, Wrestling will begin practice, Wrestlastics registration will be held mid November. Adult programs will run through the winter months. The Youth Center will open in December for grades 6 through 8. As Library liaison, she reminded everyone of the Book, Bake and Table Top Sale November 1 and 2.

FIRE, STREETS & SANITATION: Under Fire, Commissioner Gonzalez reported from September 1 through September 30 there were 42 fire calls, 21 non fire emergency calls and 177 EMS calls. From October 1 through 26, there were 27 fire calls, 7 non fire emergency calls and 109 EMS calls. The Fire Department covered football games, Town Day, Halloween in the Park, the High School Band Competition, the Ragamuffin Parade, the Outdoor Mall and had visited the schools during Fire Prevention Week. He cautioned the use of candles, especially during the holidays. Under Streets & Sanitation, he reported the 2008 Road Resurfacing Program was completed on October 22 which included Washington Place from the Boulevard to Woodside Avenue, Cleveland Avenue from Wood Street to Woodland Drive, Oldfield Avenue from Franklin to Passaic Avenues and the entire length of Railroad Avenue. Prior to repaving Railroad Avenue, the DPW rebuilt a stormwater catch basin. He continued that Leaf Season has started and residents may place leaves in the street (not within 10 feet of a stormwater catch basin), or placed at the curb in paper leaf bags or upright containers. Leaves in plastic bags will not be collected. Limbs, branches, or bush must not be mixed in with leaves but separately bundled and tied and put at the curb for branch collection (see Recycling Calendar). The last day to put out leaves in the street is December 1, and after that they must be bagged. The Shade Tree Department with the aid of PSE&G finished the dead tree list with respect to trees affected by high voltage lines. Repairs were made to Garbage Truck 101, Garbage Truck 102, the Dump Truck with Salt Spreader and the Salt Spreader. In answer to a question, Brita water filters were not recyclable, and products such as pipes, cabinets, sheds, fences, swings, above ground pool structures, car batteries and used motor oil, tires and antifreeze must be brought to the Recycling Center.

MAYOR'S REPORT:

Mayor Heck gave her report as follows:

“Sept. 27 Town Day Saturday was a big success. Another Cloudy Drizzly day in the beginning but then the sun broke through. The Environmental and Transportation Commission again gave out Leaf bags. They continue to promote Our Recycling Container at the Central Avenue Parking Lot site from 7 am to noon; it will be there again Nov. 1 –The first Saturday of each month.

Oct. 1, Wednesday, Attended the Planning Board Meeting.

Oct. 11th Attended The Research Committee Meeting at 9 am. A special Survey is being compiled under the leadership of Bill Foley and Michael Kronyak with input from Committee Members. It will be e-mailed by Borough Clerk Ro Sees to the other 565 Towns when completed. The follow-up Survey Form thus far includes four categories covering 1. Substantial Financial Impact on the community. 2. Environmental Improvement. 3. Energy Conservation. 4. Public Good Will and within each category the same five areas: staffing, equipment, departments, programs and other.

A meeting is set for November for the Committee to review, approve and then send out the form.

Oct. 14 Police Committee Meeting was held. Dep. Commissioner Sonya Buckman, Police Chief Colaneri and I met to discuss a number of topics.

Oct. 15th. Performed a Wedding in the Council Chambers. Then I attended the Business Community Meeting.

Oct. 16th. I Attended the HH chamber of commerce Meeting at The Holiday Inn at 7:30 am. Then I met with Borough Clerk Ro Sees and Business Administrator Mike Kronyak.

6 p.m. Attended the Care on the Corner Tricky Tray event, and then attended the Fundraising Dinner Dance sponsored by the HH Education Foundation at the Landmark. I presented four awards on behalf of the Mayor and Council to HHHS Athletic Director John Tessaro Community Volunteer Anne Ciavaglia (now Mrs. Brian McMahon), HHHS Coach Nick Delcalzo, and Police Chief Michael Colaneri.

Oct. 18th, Saturday – Attended the Very Successful Board of Health Fair. The displays were varied and residents came out in large numbers to participate.

Oct. 21, Saturday, 7:30 a.m. Attended the Bergen County League of Mayors

Breakfast: at the Arena Diner. U.S. Attorney Chris Christie was the Guest Speaker. He spoke at length about the 131 indictments made by his office with results of 131 convictions. He stressed the need for federal investigations on the ever-growing gangs, such as The Bloods, and The Latin Kings, and how they are the "Mafia" of the 21st Century and are on our doorsteps. He commended the local Law Enforcement, Police Departments, their work. He gave us details of the numerous arrests made beginning with Pleasantville, a community outside Atlantic City, where his department just picked a name. A Health Insurance L.L.C., made up cards, and were able to get the mayor of that town to come forward asking for \$25,000 to get that town's business and a couple of thousand for the Council. That grew into his recommendation where other towns did business that same way. That resulted in two Assemblymen who held office in those areas and who asked for the same Dollars to get each of those towns' business. They were indicted and the rest is history. He said they could have gone on to other towns, but time did not allow, since those towns would not have been covered by real insurance and they had to stop.

He did note that by this time next year there should be arrests made in the Finance/Banking area; this in answer to the Mayor of Alpine who asked what about the mess in the finance area that we are feeling nationwide and those CEOs leaving with Millions of dollars in pay. Christie responded the investigations are already in progress and you should be reading about indictments this time next year.

At 9:30 a.m. that same day, I was a Panelist at Bergen Leads. Assemblywoman Valerie Huttle and Former Freeholder Elizabeth Randall who now serves as the Board of Public Utilities Commissioner were on the Panel as well with Former County Executive William "Pat" Schuber, Chair of Bergen Leads. We spoke and answered questions to approximately 50 people in attendance. They are part of a year long, once a month study group of future leaders, who were given a "scholarship" to participate.

Oct. 22 Wednesday, 7 pm Attended the TANAAC Meeting in Moonachie. As Chair of the Legislative Committee, I recommended a priority to be addressed in the Year 2009 to be a study of the Airport Radio Tower Operators, training and equipment and that of the area TriCon Air Traffic Control Operations in the New York Metropolitan Area. I said this safety measure is something that should be addressed and recommendations made to the U.S. Senators and Congressional Leaders. The idea was met with enthusiasm and the need for same endorsed. The Committee will meet with the Airport Manager and Radio Tower Director.

Friday Oct. 24th attended a special service and tea, at Corpus Christi School given by the Eighth Grade Students.

During September and October, Mayor's Business Community Committee had several meetings to both complete the planning for the Oct. 25th – Second Outdoor Mall and to hear Promoters who work in other towns on an annual basis. They gave complete background information and each gave the Committee a long list of town names in which they work. An analysis is in the process of being made for the year 2009 and I will give a report as soon as that is completed.

Yes we had a very windy, rainy day for our Second Outdoor Mall. It proved to be a success event though about half of the 30 some odd vendors we expected did not attend. Those who did had a successful day. The people who attended enjoyed the event under the Big Tent. Prizes every hour on the hour were given out and all were in good humor. My thanks again to Coordinators David Fanale of Century 21 Eudan Realty and Bill Lenox of Lenox Towing with the assistance and cooperation of Chamber of Commerce President Ray Vorisek of The Heights Flower Shoppe and Fritz Rethage of The Gazette and Jason Cosimano of Otterstedt Insurance along with members Ron Kistner of Hekemian, Tom Meli Mickey's Foundation, Joe Manginelli of Fresh Affair, Maryellen Courtney of Gateway Realtors, Sam Papsavas of BeJay Drugs, Joe Costa of IHOP, Bill O'Shea of O'Shea's Florist and Gifts, , Jack Zaorskof the Ivy Inn, Al Hamdi General Mgr. of The Hilton Hotel and Bill Kundert of Kundert Motors.
