July 26, 2011

A Regular Meeting of the Mayor and Council of the Borough of Hasbrouck Heights was held on Tuesday, July 26, 2011 at 8:05 p.m. at Borough Hall, 320 Boulevard, Hasbrouck Heights, New Jersey.

Borough Clerk Rose Marie Sees stated that the meeting complied with the Sunshine Law, adequate notice of this meeting having been made to all members of the Council by personal service on January 3, 2011 and transmitted to The Observer, The Record and The Herald News on January 3, 2011.

REPORTS:

POLICE AND LAND USE: Under Police, Commissioner DiPisa reported the Department participated in MDA's Annual Lock Up on June 28. The 12th Annual Jr. Police Academy held June 27-July 1 had the largest class ever. The recruits participated in many activities including self defense, motor vehicle stops, team building and more. They took trips to Bergen County Police Academy and a tour of the Bergen County Jail. Guest instructors were from the FBI, NJSP, B.C. Sheriff's Dept., Lyndhurst SWAT Team along with H.H. Teacher Mike Stillman, Det. Sgt. Joe Rinke and Det. Mike **POLICE AND LAND USE (cont'd):** Colaneri. A new evidence record keeping system

was purchased using confiscated funds. The state of the art system will save officers time tracking and ensuring proper handling and tracking of all evidence from the scene to the lab and court room. It is compatible with the Bergen County Prosecutor and NJ State Police Lab. Det. Colaneri did the research and oversaw the installation of the system. He read two letters, one from the Shaw Family thanking the Police and EMT for their responses to 94 Wood Street to assist their Dad and another from B.C. Sheriff Michael Saudino for participation in the "Chief for a Day" celebration. Under Violations, he reported under parking violations for the month of July in 2011 were 2,125, in 2010 there were 1,702. Moving violations in 2011 were 814, and in 2010 were 716, with total violations in 2010 of 2,418 to 2,939 in 2011.

FINANCE, SOCIAL SERVICES & PUBLIC FACILITIES: Under Finance, Deputy Commissioner DiPisa reported the Current Fund cash balance at June 30 was \$502,337.49 and at May 31st was \$3,077,289.16 which represents a decrease of \$2,574,951.67. The entire balance was invested and earning approximately 0.35%. Cash receipts for the month of June totaled \$324,894.54 of which \$138,320.62 was for Current Taxes, \$20,848.12 was Delinquent Taxes and \$165,725.80 was Miscellaneous Revenues. Cash disbursements for the month of June totaled \$2,897,108.45 of which \$1,919,932.75 was for Local School Taxes, \$601,459.80 was for Salaries and \$375,715.90 was for Other Expenses. He continued that estimated tax bills were printed and mailed with a due date of August 1, 2011. The Finance Department received the Certification of Final Tax Rate and is being reviewed. Once all numbers are confirmed final tax bills will be mailed which will reflect the fourth quarter 2011 balance and first and second quarter taxes for 2012.

PUBLIC FACILITIES: Under Public Facilities, Deputy Commissioner DiPisa reported the air conditioning systems at several of our buildings, maintenance of the entire system at the Municipal Complex was completed by installing new filters and cleaning of the compressors cooling coils. Fan belts were also replaced where needed throughout the system as well. At Police Headquarters, a new compressor unit was installed that controls the area of the Police Desk. The new compressor was not in stock and took two days until it was available. During this time, a portable A/C unit was placed at the desk to keep our 911 system from overheating until the repair was completed. A malfunction of the fire alarm system was detected at Borough Hall. The cause of the malfunction was a faulty wire connection in the terminal control box. The repair was completed in a timely fashion. The Senior Picnic was held at the Senior Center on Thursday, July 14. The DPW assisted Ro Sees, Borough Clerk, who organized the event, with the set up of tables, chairs, an outdoor grill, and a canopy. The schedule of meetings was as follows: Community Room – 7, Caucus Room – 7, Council Chambers – 4 and Senior Center – 3.

SOCIAL SERVICES: Under Social Services, Deputy Commissioner DiPisa reported the Food Pantry is at its lowest ever! As you have been reading about most Food Pantries **SOCIAL SERVICES (cont'd):** in our area, the Hasbrouck Heights Food Pantry is also

in desperate need of supplies. The shelves are almost empty save for some canned vegetables and lots of pasta. Items to be donated could be any grocery items including but not limited to canned soups and meats, tuna fish, cereals, sauces and gravies, coffee, tea, sugar, flour, powdered milk, toiletries, paper products and cleaning products. Grocery store gift cards in denominations of \$5 or \$10 are also gladly accepted. Everyone has been so generous in the past, which is very much appreciated. Donations may be dropped off at the Borough Clerk's office from 8 a.m. to 3:30 p.m. Monday through Friday. From June 27 through July 25, there were 104 visitors to the Food Pantry who received food and a food store gift card when available. We would like to especially thank the following for their wonderful generosity in providing monetary donations, groceries or gift cards: Mrs. Caputo, Mr. Kinsley, Arlene Carreau, Martha Pertuz, Mr. Mion, the First Reformed Church, Kathy Van Jura, Tribeca Ovens and The Bread Man, Maria Wojchechowski, St. Joseph's Church in Lodi, Methodist Church and Corpus Christi Brown Bag Sunday. The food pantry is open on Monday mornings from 9am-11am for Hasbrouck Heights residents in need. Anyone in need can register by calling Rob Brady at (201) 288-4143. Thank you to the generous volunteers who help stock and supervise the food pantry.

RECREATION & PARKS: Under Parks, Commissioner Buckman reported the United Water Company had notified the Borough that water meters were scheduled to be replaced at Woodland Park. The DPW had scheduled a date to meet with the technician at the park to discover that one of the meters had long been disconnected and buried over and the other meter linked to a drinking fountain was removed some years back from the playground area. Both the water company and the Borough Clerk's office were notified and the matter is being looked into. At Woodland Park, Recreation Camp is still going on and the DPW removes trash and cleans the bathrooms facilities every day. Michael Kronyak, Borough Administrator, along with Bill Spindler, DPW Superintendent, and Ken Job, Borough Engineer, met several times at the Firemen's Memorial to discuss the improvements to the park. One of the latest communications, regarding the construction of the area, between Spindler and Job was with United Water Company. The installation of a vault box was requested by the DPW for irrigation valves to a new sprinkler system. Ken Job had to provide certain specs to the water company to complete the order.

Under Recreation, Commissioner Buckman reported Softball UGALS 10 and under continue to do well in the playoffs against Ridgefield. UGALS 12 and under are the top seed in their division playoffs and consequently have field advantage in their playoffs with Wood-Ridge tomorrow. They were wished well. Summer Recreation Program is winding down. The last few trips are Liberty Science Center, Medieval Times and the Ice House in Hackensack with the last day of the program Aug. 5. Town Day is scheduled at Woodland Park for Saturday, Sept. 24 with a raindate of Oct. 1. Organizations are invited to call Rob Brady or e-mail him at hhrec@aol.com for a table. STREETS, SANITATION & TRANSPORTATION: As Commissioner, Councilman Gonzalez reported During this past month, several repairs were performed at the Franklin Avenue Sanitary Sewer Pump Station. While performing a routine inspection of that facility, the pump room was found to be flooded with four feet of water. Our Jet-Vac vehicle along with a portable pump was dispatched immediately to pump out the water. Once this was accomplished, it was discovered that one of the three pumps had seized up and broke the seal to the underlying pipe along with the drive shafts. The main valve was shut off to stop the flooding and then the repairs could begin to take place. The entire pump was removed and had to be totally rebuilt along with new universal joints and drive shafts. During the period of rebuilding, the facility operated on two pumps at which time another pump began to indicate that the bearing in that pump were torn-up and that pump was also taken out and rebuilt. The Pump Station is now back in full operation with all three pumps functioning. However, there are still some electrical repairs that have to be addressed. On June 29 the Police Department reported to the DPW water flowing out of a manhole on Rt.17 South in the area of Houlihans. DPW call men were dispatched to investigate the matter. They found a blockage in the sanitary sewer line that runs under the highway. All safety equipment and assistance from the Police Department was used to close off two lanes of traffic. The blockage was cleared from the system. The DPW provided cones and barricades to block off streets during the fireworks display held at Depken Field. After the event, they cleaned all debris/ash from the Little League Field area that was left behind from the fireworks. Backpacks and walk-behind blowers were used as well as the street sweeper. As Environmental liaison, he reported the Satellite container will be in the municipal lot on Saturday, Aug. From 7 a.m. to 12 noon.

FIRE: Under Fire, Commissioner Dingertopadre said he had not received a report.

HEALTH: Under Health, Commissioner Lipari reported on the following:

Senior Flu Shot Program: The Health Department in conjunction with the Mid-Bergen Regional Health Commission is offering adult influenza vaccine injections to residents over 65 years of age on Sept. 29, 2011 from 10 a.m. to 12 noon in the Senior Center. Adults 65 years and older are required to bring their Medicare card (Part B). Residents who are covered by Managed Care Plans (HMO) are requested to see their private physicians for the vaccine. Adults under 65 and/or those who do not have a Medicare Part B Card will be charged a fee of \$20 for the vaccine. Limited vaccine is available for those under 65 years of age. Advance registration is required and will begin on Thursday, Sept. 15 at 9 a.m. at Borough Hall. ORDINANCE(S) ON PUBLIC HEARING:

ORDINANCE NO. 2267:

Mayor Heck requested a motion to open the public hearing on Ordinance No. 2267 which was made by Councilman DiPisa, seconded by Councilman Gonzalez, and unanimously carried.

Carol Skiba, 191 Field Avenue, questioned Ordinance 2099, adopted August 9, 2005, 275-27of the Zoning Code entitled "Continuation of lawful nonconforming uses, structures and lots", saying it was amended to say "A use, structure or lot which is lawfully conducted or in existence prior to the effective date of any ordinance rendering such use, structure or lot nonconforming shall become a lawful nonconformity and may lawfully continue either in the manner as it was conducted or to the same extent as it existed prior to the adoption of that ordinance without any constraint whatsoever as hereinafter provided." She questioned if any nonconforming use of parking rental spots and lots throughout the borough continue to exist as they were prior to the introduction of this parking ordinance.

Mr. Chandless said this issue was raised by the Zoning committee. What business was conducted by the moratorium was the strict application of the ordinance that prohibited the rental of parking was lifted and did not then mean that those uses became lawful, in other words the ordinance was never amended to make whatever uses were undertaken under the moratorium lawful. The purpose of the moratorium is to test out proposed uses.

Mayor Heck said this ordinance also has to go before the Planning Board before it is adopted.

Joseph Audino, 116 Oldfield Avenue, which is across from the VFW. He said constantly there are cars parking overnight, all week long, a trailer was parked for a

couple of months. Now he said you want to have strangers park there from 6 p.m. to 8 a.m. He was told they were those persons permitted by the VFW, the arrangements are private. What was being controlled was the size of the vehicles, length of time they can be there, they have to be removed during the daytime. He said a motorcycle club meeting is held (at the VFW) every Friday with motorcycles going up and down Field

Avenue until 2 a.m. Mayor Heck said this issue should be looked into further and asked Capt. Cronin look into this, who said if this is a function at the VFW and they are invited guests by the members of the VFW, there isn't much that can be done. When asked what their hours of operation were, it was thought they followed the ABC guidelines which were 1 or 2 a.m. on the weekends. He was told that the Building Inspector, before the VFW will be permitted after the first year, will make a determination that parking is available and designate parking spaces to limit it. Mr. Audino questioned 8 a.m. – would there be a patrol car there at 8:01 a.m. He was advised to call the Police if he observed cars. He was also told parking is limited to residents.

Judi Ferrari, 117 Baldwin Avenue, said that she has lived across from the Elks for 30 years. After 15 years the neighbors were no longer allowed to park in the lot. However, they have allowed various businesses to park their vehicles there. She has observed box trucks and landscaping vehicles and a tractor trailer which was there from 5 a.m. to 3 p.m. yesterday. She took pictures today and the day before which she presented and passed around of what she looks at. She was concerned that if cars would now be allowed to park, would she be looking at 15 cars. She was told the Zoning Enforcement Officer will make a determination of where the parking spaces will be. With the ordinance if the Elks has sufficient parking between 8 p.m. and 6 a.m. and if they want to rent it can only be residents and vehicles in accordance within the limitations of the ordinance.

There being no one else wishing to speak, Mayor Heck requested a motion to close the Public Hearing on this ordinance which was made by Councilman Lipari, seconded by Councilman Gonzalez, and unanimously carried.

Mayor Heck asked for a motion to Continue the Public Hearing on this ordinance until August 9, 2011 which was made by Councilman DiPisa, seconded by Councilman Gonzalez, and unanimously carried.
